- iii) To provide a provision for joint supervision of M.Sc/ M.Tech./Ph.D students

3. Proposed mode of Collaboration

DoM-MGSU and ECB propose to collaborate through the following:

- i) Cooperation and promotion of education and training in areas of mutual interest.
- ii) Any other appropriate mode of interaction mutually agreed upon between DoM-MGSU / ECB.

4. Joint Sponsored Research and Consultancy Projects

DoM-MGSU and ECB staff will undertake jointly sponsored research and consultancy projects according to the following terms:

- i) Project proposals will be formulated jointly by the concerned faculty/experts of the two Institutions.
- ii) Project would require approval of both the Institutions.
- iii) Income arising out of the consultancy works will be shared by the two Institutions on the basis of inputs and approved norms in each Institution. Consultancy/ manmonths and cost of project will be calculated on the basis of input.

5. Terms and conditions

- iv) The cost of infrastructure development at DoM-MGSU / ECB should be borne by the concerned Lab.
- v) For continuing training and research support to DoM-MGSU / ECB teachers, staff, research scholars and students, the financial arrangement will be made on mutually agreed terms.
- vi) For the visits related to advice and consultancy, travel and other expenses of DoM-MGSU / ECB faculty, staff, scholars and students shall be reimbursed by the respective Lab/University on mutually agreed terms.
- vii) Usage of DoM-MGSU / ECB academic infrastructure can be allowed, subject to its availability, approval of the respective Head of the facility/ department and/or respective University/ Institute norms.
- viii) This MoU may be amended, renewed and terminated by mutual written agreement of the *Labs* at any time.
- ix) Either Department shall have the right to terminate this MoU upon 60 days prior written notice to the other *Lab*.

6. Confidentiality

- i) The DoM-MGSU and the ECB agree to hold in confidence all information/data designated by the *Labs* as being confidential which is obtained from either *Lab* or created during the performance of the MoU and will not disclose the same to any third party without consent of the other *Lab*.
- ii) The above confidential clause under the MoU excludes the information/data possessed by either *Lab* before entering into this MoU or independently developed and/or information already available through public domain.

7. Duration of MoU

This MoU, unless extended by mutual written consent of the Labs, shall expire in five years after the effective date specified in the opening paragraph. However, on review, the MoU shall be extended for another period of time on mutual consent.

8. Coordinators

Both the Head of departments or Nominated members would coordinate and implement this agreement.

9. Intellectual Property Rights & Research Publications

The intellectual property (IPR) rights that arise as a result of joint research and collaborative activity under the agreement will be worked out on a case to case basis and will be consistent with officially laid down IPR policies of the two.



THE MEMORANDUM OF UNDERSTANDING (MOU)

2. Maharaja Ganga Singh University(MGSU), a State Multi-faculty University, Bikaner, Rajasthan, India herein after referred to as "MGSU" with a committed mandateof strengthening four-fold fundamentals of higher education-teaching, research, extension and consultancy

Both SKRAU and MGSU jointly agree:

- 1. To undertake joint research projects in the areas of mutual interest.
- 2. To share the facilities for carrying out collaborative research and other academic programmes.
- 3. To organize academic activities and development programmes of mutual interestpotentially beneficial and agreed by both the Universities.
- 4. To share laboratory, research farm, library and other supporting facilities for joint research projects as well as for students.
- 5. To facilitate and coordinate student research work and permitting the faculty to be member/ co-advisor of advisory committee(s) for teaching and guiding students of both the universities.
- 6. To share research results and publish jointly in collaborative projects.
- 7. Any IPR emerging from collaborative project will be the property of both the Universities in proportion to contribution of the investigators, as per Government of India rules.
- 8. In case of projects not supported formally by an extramural grant, but otherwise to by the two Universities, the parties shall meet their respective expenses which they might incur while carrying out their respective agreed obligation.
- 9. Neither of the parties shall claim the usage of facilities/software or other services as a matter of right. It would be subject to availability, but would not be ordinarily refused.
- 10. This MoU is non-binding, non-enforceable and nor financial ramification, but rather a way of mutual understanding for increasing both universities a mutual synergic benefits.

Implementation:

Both the universities shall designate a liaison officer to develop and coordinate specific activities or programmes. The terms of such activity of mutual interest shall be discussed and agreed prior to the initiation of the activity. During operation, if any alteration / modification is required, the same may be mutually discussed and duly agreed upon in writing.

Timeline:

This MoU will be effective from the date of its signing by both the parties shall remain in operation for a period of 5 (Five) years from the date of signing, until one of the parties serve notice to the other for its intention to terminate it. In such instances, the MoU will stand terminated 3 (three) months from the date of such notice. In case both the universities agree to terminate the MoU, the ongoing research projects will be completed as per already signed MoU and agree obligations.


Renewal of the MoU:

- Resource Sharing: Both the parties agree to share the common resources such as Instrumentation centre, Laboratories, Libraries, IT services, Infrastructural resources, etc. for the researchers and faculties.
- 5. Joint Faculty Development Programs: Both the parties intend to organize collaborative Faculty Development Programs.
- 6. Joint Skill Development Programs: Both the parties intend to organize employable skill development programs with the help of industries for the mutual benefits of students and community at large.
- Faculty Exchange: The faculty members from BNU will be eligible for teaching of specific subject for utilizing the benefits of their expertise in the subjects. The faculty members engaged in the specific courses shall be eligible for honorarium for teaching assignment as per the regulations of MGSU.
- 8. Financial Obligation: In case of projects not supported formally by an extramural grant, but otherwise by the two Universities, the parties shall meet their respective expenses which they might incur while carrying out their respective agreed obligation.
- 9. Both parties agree to organize Joint Conferences, Seminars, Workshops, Conventions, placement drives and Students cultural Festivals.

- 10. Both parties intend to sign Joint Memorandum of Agreements with Industry as per requirements of various departments from BNU as well as MGSU.
- 11. Both parties agree for Joint publication and dissemination of outcome of collaborative projects and research.

IMPLEMENTATION

The President (Vice Chancellor) of The BNU and The Vice Chancellor of The MGSU shall be responsible to work out operational framework and ensure effective implementation of The MoU.

The Registrar on behalf of The President of The BNU and The Registrar of MGSU on behalf of The Vice Chancellor of The MGSU shall be the Executive Heads for the effective implementation of The MoU.

However, the Deans of the respective faculties of both parties shall execute all the mutually agreed operational decisions.

Any intellectual property rights emerging from collaborative projects will be the property of both the Universities (BNU & MGSU) in the proportion to contribution of the investigators as per the prevailing norms.

COMMENCEMENT AND VALIDITY

The MoU shall remain enforced for a period of FIVE Years from the date it is signed by the concerned signatories of the two Universities. It may further be extended or amended with the written agreement of both the parties. The MoU may be terminated by the either party subject to the delivery of six month advance notice, in writing. In case both the Universities agree to terminate MoU, the ongoing Research Projects shall be completed as per already signed MoU and agreed obligations.

TERMS AND CONDITIONS AND OPERATIONAL FRAMEWORK

It is understood that The BNU and The MGSU subscribe the principles of equal opportunity and do not discriminate on the basis of race, sex, age, caste or religion. Both the Universities shall abide by these principles in the administration of this MoU.

Both the parties agree for Biannual Review meeting to ensure effective implementation of the above foresaid activities and necessary improvements.

Unforeseen issues, not covered by the MOU will be discussed for mutually agreeable solution.

This MoU has been executed in two originals, one of which has been retained by The BNU and the other by The MGSU.



BACKGROUND OF MOU:
