Allocation of Seats for Limited Applications	It was decided that programmes with a limited number of applications have the option to allocate available seats initially based on the received forms, specifically for regular programs (not for SFS). Simultaneously, offline applications for these programs will continue to be accepted until the 12th of August.	Implemented
Offline Applications for SFS Programs	It was decided that if there is an insufficient number of online applications for SFS programmes, offline applications for these programs will also be kept open until the 12th of August.	Implemented
Completion of Admission Process	It was decided that the admission process in all programmes should be completed by 14th August 2023.	Implemented
Responsibility of Coordinators for SFS Programs	It was decided that the coordinators have the responsibility to ensure that a minimum of 50% of the seats for a given SFS program are occupied. If the number of vacant seats exceeds 50%, the SFS program will not be continued for that particular session.	Recorded
Notification Regarding Vacant Seats	It was decided that the notification regarding admission against vacant seats for a particular programme including SC/ST seats, after the first counselling will be available on the University website through the respective department/programme coordinator. LLM Program Admission Process	It was decided that the preparation of the merit list, counselling, and fee deposition for the LLM program will be conducted	Recorded
