NOTIFICATION

(For Admission to Ph.D.)

Online applications are invited for Ph.D. Admission 2025 in various subjects as per provisions of University Research Ordinance 101 and University Grant Commission's (Minimum Standards and Procedures for Award of Ph.D. Degree) Regulation, dated 7th November, 2022, U.G.C. Public Notice No. 140648 Date 27-03-2024 "National Eligibility Test as an entrance test for admission to Ph.D." and Standard Operating Process and Procedures (SOPP) of MGSU amended from time to time. All the above Ordinances/regulations/SOPP are available on the website of MGS University, Bikaner and can be accessed using the web link https://www.mgsubikaner.ac.in/research-ordinances.

Eligibility: As per University Research Ordinance 101, University Grant Commission's (Minimum Standards and Procedures for Award of Ph.D. Degree) Regulation, Dated 7th November, 2022 and U.G.C. Public Notice No. 140648 Date 27-03-2024 "National Eligibility Test as an entrance test for admission to Ph.D."

Number of Seats available: As per the details given in this notification.

Ph.D.Admission: Admission to Ph.D. in different subjects will be made subject to availability of seats as displayed on the University website and mentioned in the notification. The JRF qualified candidates with fellowship/scholarship (Category 1) will be admitted in the order of merit prepared on the basis of the interview score. For students qualifying in Category 2 and 3, 70% weightage will be given to NET score and 30% weightage to the interview. The admissions will be given in the order of combined merit of marks obtained in NET and marks obtained in interview.

Reservation of Seats: As per the Reservation Policy of the Rajasthan State Government mentioned in the Admission Policy in force.

Application Form: To be filled online from **05-07-2025 to 18-07-2025** and hard copy to be submitted latest by **25-07-2025** (**5.00 PM**)

Application form must be submitted along with the online fee receipt and attested copies of supporting documents including:

Mark sheets/Certificate of Secondary, Senior Secondary, Graduation, Post Graduation, NET, NET-JRF. Latest valid Caste Certificate (SC, ST, OBC and MBC), EWS Certificate, Domicile Certificate and Physically Handicap Certificate (Differently-abled).

Note:

1. The Certificate regarding OBC/MBC (Non Creamy Layer) and EWS category is valid for one year. However, after expiry of the certificate if the candidate of the above category is eligible as per the prescribed criteria for these categories, certificate issued earlier will be accepted on the basis of certified affidavit produced by the candidate for next two years along with copy of the original certificate concerned.

- 2. If a candidate fails to provide latest valid OBC/MBC Non Creamy Layer Certificate, he/she will not be given category benefit and shall be considered in UR category.
- 3. Domicile Certificate is required to avail benefit of reservation category.

Application Fee: Rs. 3000/- for candidates of Unreserved/OBC(creamy layer) category and Rs. 2500/- for the candidates of SC/ST/OBC (non creamy layer) /MBC /EWS category. Fee is to be paid online through University website only. The candidates who wish to apply in more than one subject have to deposit separate fee for each form.

- 2. Permission to appear in the interview does not guarantee the eligibility for the admission. All the applicants who fill up the online application form will be provisionally allowed to appear in the interview.
- 3. University reserves the right to cancel the admission to Ph.D. even at a later stage if the candidate fails to fulfil eligibility criteria.
- 4. Eligibility and other conditions as on last date of filling the online application form shall be considered. Any addition/changes thereafter will not be entertained.
- 5. Candidate must keep printout of application form and proof of fees receipt for his/her personal record.
- 6. All legal matters related to Ph.D. Admission 2025 shall be subject to the jurisdiction of Rajasthan High Court, Jodhpur.

Eligibility Criteria, General Rules and other Information

(1) APPLICATION FEE:

Rs. 3000/- for candidates of Unreserved/OBC(creamy layer) category and Rs. 2500/- for the candidates of SC/ST/OBC (non creamy layer) /MBC/EWS category to be paid online through University website. The candidates who wish to apply in more than one subject have to deposit separate fee for each form.

(2) ELIGIBILITY:

The following are eligible to seek admission to the Ph.D. programme:

(A) Candidates who have completed:

A 1-year/2-semester master's degree programme after a 4-year/8-semester bachelor's degree programme or a 2-year/4-semester master's degree programme after a 3-year bachelor's degree programme or qualifications declared equivalent to the master's degree by the corresponding statutory regulatory body, with at least 55% marks in aggregate or its equivalent grade in a point scale wherever grading system is followed or equivalent qualification from a foreign educational institution accredited by an assessment and accreditation agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country to assess, accredit or assure quality and standards of the educational institution.

A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC and MBC (non-creamy layer)/Differently-abled, Economically Weaker Section (EWS) and other categories of candidates as per the decision of the Commission from time to time.

Provided that a candidate seeking admission after a 4-year/8-semester bachelor's degree programme should have a minimum of 75% marks in aggregate or its equivalent grade on a point scale wherever the grading system is followed. A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC and MBC (non-creamy layer)/Differently-abled, Economically Weaker Section (EWS) and other categories of candidates as per the decision of the Commission from time to time.

(B) Candidates who have completed the M.Phil. programme with at least 55% marks in aggregate or its equivalent grade in a point scale wherever grading system is followed or equivalent qualification from a foreign educational institution accredited by an assessment and accreditation agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country to assess, accredit or assure quality and standards of educational institutions,

shall be eligible for admission to the Ph.D. programme. A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/Differently-abled, Economically Weaker Section (EWS) and other categories of candidates as per the decision of the Commission from time to time.

(C) Ph.D. THROUGH PART TIME MODE: -

- (a) Ph.D. programmes through part-time mode will be permitted, provided all the conditions as stipulated in University Research Ordinance are fulfilled.
- (b) The candidate will produce a 'No Objection Certificate' for part time Ph.D. programme from competent authority of the organization where the candidate is employed. Such certificate should clearly state that:
 - i. The candidate is permitted to pursue studies on a part-time basis.
 - ii. His/her official duties permit him/her to devote sufficient time for research.
 - iii.If required, he/she will be relieved from the duty to complete the Course Work.

(3) ADMISSION PROCEDURE: -

The eligible candidates having qualifications mentioned in above point 2 must also qualify under one of the following categories (in concurrence with the provisions of U.G.C. Public Notice No. 140648 Date 27-03-2024)

<u>Category 1:</u> Candidates with a fellowship/scholarship from national-level examinations such as CSIR/UGC-JRF, ICMR-JRF, ICAR-JRF, DBT-JRF, etc.

<u>Category 2:</u> Candidates who have qualified national-level exams like CSIR/UGC-NET or similar tests.

<u>Category 3:</u> Candidates eligible for Ph.D. admission based on the CSIR/UGC-NET examination.

Selection Process for

Candidates of Category 1:

- i. Shall be directly called for an interview provided they have valid fellowship as detailed out in SOPP available on the university website.
- ii. The interview will carry 30 marks.

Candidates of Category 2 & 3:

- i.70% weightage will be given for NET scores and 30% weightage for the interview.
- ii. The interview will carry **30 marks**.
- iii. The final merit list will be prepared based on the combined score of NET and interview.

Note:

Qualified candidates, maximum twice the number of seats, shall be called for interview to discuss their research interest/area, their research aptitude and relevant knowledge.

(4) COURSEWORK

- i. The candidate selected through above procedure will have to take Course Work as per the University norms.
- ii. 75% attendance in the Course Work classes will be compulsory to acquire eligiblity for the Course Work examination.
- iii. Duration of Course Work shall be of 6 months. This period will be included in duration of Ph.D. Programme.
- iv. The candidate must obtain a minimum 55% marks or equivalent grade point to pass the Course Work.
- v. In case a candidate fails in Course Work examination fully/partially, he/she shall be given one more chance and will be allowed to reappear in the ensuing Course Work examination conducted by the University on deposition of prescribed fee/registration fee as per the University Norms.
- vi. If a candidate fails to clear Course Work examination in two attempts, his/her admission will be treated as cancelled.

(5) DURATION OF Ph.D. PROGRAMME

- i. Ph.D. programme shall be for a minimum period of three (3) years including Course Work and maximum of six (6) years from the date of admission to the Ph.D. programme.
- ii. A maximum of an additional two (2) years can be given through a process of re-registration as per the University Ordinance; provided, however, that the total period for completion of a Ph.D. programme should not exceed eight (8) years from the date of admission in the Ph.D. programme.

Provided further that, female Ph.D. scholars and Persons with disabilities (having more than 40% disability) may be allowed an additional relaxation of two (2) years; however, the total period for completion of a Ph.D. programme in such cases should not exceed ten (10) years from the date of admission in the Ph.D. programme.

iii. Female Ph.D. Scholars may be provided Maternity Leave/ Child Care Leave for up to 240 days in the entire duration of the Ph.D. programme.
